Trevor – There is a part of this that says AVTB can still look at their criminal record and make recommendations regarding employment or serving on AVFD.

- The chief is a position of honor so is serving on the AVFD. The whole department runs on a volunteer effort. I was hoping to provide an incentive to our chief.
- Motion by Trevor Dolby to pay the chief \$25.00 for every monthly business meeting she attends.
- Motion fails for lack of a 2nd.
- Jack Sypolt I do not agree with position and Pay structure. There used to be a pittance that was provided when I was with the fire department. The volunteers to incur costs in serving.
- Pat Is the Chief a paid position?
- Joe Cohan No
- Pat we need to look at this as a paid position
- Sharon Little Couldn't we ask the chief to submit vouchers for re imbursement of expenses?
- Pat We would be better to provide a monthly set amount. \$200.00 per month would help cover costs.
- JW I have learned to have a great respect for the AVFD and the Ambulance Department. They have hauled my *** to the hospital a number of times in the last few months. The Chief should receive something.
