Vance Payne - Manager Nye County Emergency Management Services.

Ken – What is status of training for the AVFD for training on safety and equipment?

Vance - Amargosa Valley does not answer to my department

I am responsible for tracking risk assessment for the Nye County Board of Commissioners. My staff has noticed some safety issues at numerous call outs in Amargosa Valley

The Standards that we are looking for are dictated by the National Fire Protection Association. They are designed to protect the safety of Fire Fighters and Equipment and every fire department is supposed to uphold those standards

Nye County Board of Commissioners is ultimately responsible for the risk of any department in Nye County. It is my job to keep them apprised of what is going on with Emergency Services in Nye County.

Regarding the letter that I sent you if there is no attempt at compliance with NFPA Standards by the end of the month they make take action to re claim the equipment. I am responsible for 24 people at Station 51

Please make your department safer or refuse mutual aid.

The main issues are

Liability

Safety

John – Nye County does not have a fire department ordinance. They have no authority to operate a Fire Department in Nye County. These issues need to be addressed. I would like to know which standards were violated.

Vance – Violations were for safety reasons of fire fighters and equipment

How can Nye County help Amargosa Valley Fire Department?

John – We have a fire department ordinance – and have tried to co ordinate with all county units – I am alarmed that we may lose mutual aid

Joe – Vance is here to try and help us

Ken – What is the short cure?

Vance – Have your firefighters wear their protective gear and improve their adherence to NFPA standards

Joe - Vance is here to help us with a safety program

Vance – You need a training plan that adheres to NFPA standards and follows guidelines set by the State Fire Marshall. The State Fire Marshall has reached out to Amargosa Valley You might look at getting a new person to handle the training.

Nita Fuller - Could Nye County EMS help with training?

Vance – Volunteerism is slowing down across the county so staffing a volunteer fire department is tough to do. Matt Clayton is our training manager. All the volunteers in Gabbs are over 65 we have had to adjust the program and equipment to fit what they have.

Nita - How many people do you need in a class?

 $Vance-The\ classes\ can\ be\ scheduled\ over\ 5-6\ months\ and\ some\ can\ be\ taken\ online.$

Tom Smith - I am a homeowner here and live 10 miles from the fire station. Many homes are 20 to 30 miles away and go up in 15 minutes. Beatty is only a one mile radius. We have a long response time to cover over 400 sq miles. Our training needs to fit the area.

Vance – NFPA Standards cannot be adjusted for the location. A rural area has the same standards as a small town.

Claudia Bowker – My family has a history in fire fighting. What % of our fire fighters are adequately trained?

Trevor – We are always short of quality fire fighters

Claudia – Would Nye County consider an outpost of firefighters in Amargosa Valley?

Vance – That was done years ago. The county's financial situation does not allow us to do that now. That problem is not specific to us. We have had to close fire departments up north.

Trevor – It has been done. In 2009 we had 20+ people show up at meetings. In 2008 we had a firefighter 1 training class that lasted 8 months.

Claudia – It may be necessary to pay for fire department personnel

Joe - We need to establish a firefighter safety training program

Vance – Can I contact the State Fire Marshall for you?

Bob Little - We need to get the training manuals and get a program started

Gloria Anjelino – The letter states you need a response by January 31st.

Vance-I will be reporting to the BOCC on any progress we have made.

Paid Fire Chief position for Amargosa Valley. Formation of Committee to set criteria.

Pat Minshall – The actions of Nye County and the Town have gotten us into this mess.
