NCSO SPENDING PROPOSAL IS AS FOLLOWS:

- Reoccurring costs for Mobile Data Terminals -- \$1,500.00
- Reoccurring costs for Mobile Spillman -- \$540.00
- Reoccurring costs for Jail Medical Contract -- \$3,750.00
- Reoccurring costs for Dash/Body Cameras -- \$3,243.24
- AED in each Deputy in central area command with adult/child's pads & battery -- \$5,652.50
- First Aid medical bag with supplies for each Deputy -- \$529.95
- Upgrade and refresh for the Virtra Training System -- \$13,344.85

Leaving a balance of \$2,179.86 that we would ask the board to roll-over to next year.
